WITHDRAWAL AND REFUND POLICY

This Policy and Procedure is in compliance with National Code 2018 Standard 2 and 7

Background

This policy outlines the required notice for withdrawal from studies with ASC International and the refund applicable for tuition fees only. This policy is strictly adhered to and should be read carefully.

Definitions

ASC Connect – Subjects, delivered via remote education, such as Ea/LD, by schools of The Anglican Schools Commission Inc.

Commencement Date– the date when the student begins studying whether remote or on-campus. For Flexi courses, this is the first date the resources are made available to the student, for study.

Confirmed Commencement Date – For students without a student visa, this is the date the Letter of Offer or Course Confirmation Letter is signed. For those students with a student visa, this is the date which is confirmed either in writing or verbally with the Enrolments or Marketing Officers.

EaL/D – English as an Additional Language and/or Dialect

Language School Courses – Courses delivered under the ASC Language School, including CRICOS registered courses, which include all levels of Preparation for Secondary Studies and General English.

Long Term Students - students who's intended study is more than one term

Mainstream Courses – Mainstream courses refer to courses which are either Primary or Secondary School Courses, (e.g. Year 12). This includes WACE Preparation, Junior Secondary and Foundation Program Courses.

Other Short Courses – All courses that do not meet the criteria of Mainstream or Language School Courses

PSS – Preparation for Secondary Studies, can be delivered onshore or online

PSS Flexi – an online, self-guided study, language course

Short Term Students – Students whose intended study is less than one term

Policy

All requests for refund must be made in writing, via the Refund and Withdrawal Form, and addressed to the Principal and Director of International Programs. Any refund will be paid within 28 days, upon receipt of written notice by the student's parent/guardian, or within 14 days, if the school terminates the student's enrolment.

A refund will be paid by electronic transfer into the nominated bank account, less any bank charges.

Table 1 and 2 apply to all students who attend ASC International and ASC Language School in mainstream and Language School Courses. This is regardless of the mode of delivery, i.e. remote and on-campus students are subject to the same Refund and Withdrawal Policy.

Please Note, if at any time after the acceptance of the Letter of Offer the course pathway is altered for any reason, ASC International cannot guarantee your first preference school and a second preference will be provided.

In addition to the policies stated above, the following applies when a student, on an existing bursary or scholarship, withdraws from studies, prior to completion of the scholarship or bursary period:

- 1. Students must repay all scholarship or bursary amounts awarded to them for the period of study completed.
- 2. Students must pay any withdrawal, notice or penalty fees, as per the standard withdrawal policies. These fees will be charged at and are payable at full tuition rates.
- 3. All accounts must be cleared prior to any release or final assessment/reporting documentation being provided.

In the unlikely event that the ASC is unable to deliver a course which has been paid for and does not meet the ASC's obligations to either offer the student an alternative course that the student accepts or pay the student a refund of the student's unspent prepaid tuition fees (this is called a provider's 'default obligations'), the Tuition Protection Service (TPS) will assist the student in finding an alternative course or to get a refund if a suitable alternative is not found. Withdrawals due to special and extenuating circumstances can be applied to Director of International Programs for special consideration. Applications must be made in writing to <u>admissions@ascschools.edu.au</u> and evidence must be provided of the extenuating circumstances.
